THE TAHOE FUND PROVIDED FUNDING FOR A NUMBER OF SUSTAINABLE RECREATION PROJECTS AROUND THE BASIN, INCLUDING THE EXTENSION OF THE EAST SHORE TRAIL WITH FUNDING FOR NEW PARKING LOTS ALONG SR28, THE MEEKS RIDGE TRAIL ON THE WEST SHORE OF TAHOE, AND GROOMING OF XC TRAILS WITH NEVADA NORDIC.

TAHOE FUND AWARDED A NUMBER OF GRANTS TO ORGANIZATIONS THAT ARE EXPANDING ACCESS AND INCLUSION IN TAHOE, INCLUDING SOS OUTREACH TO GET UNDERSERVED KIDS OUT SKIING AND RIDING, ACCESSIBILITY IMPROVEMENTS AT WATERMAN'S LANDING, NEW INTERPRETIVE PANELS AT THE CRYSTAL BAY FIRE LOOKOUT AND MURALS IN FOREST SERVICE PIT TOILETS. THE TAHOE FUND CONTINUED TO FUND THE REGIONAL STEWARDSHIP COLLABORATION CALLED TAKE CARE TAHOE WITH NEW MESSAGES AND BILLBOARDS ON MAJOR HIGHWAYS INTO TAHOE AND WAS A MAJOR FUNDING PARTNER IN THE EXECUTION OF THE NEW DESTINATION STEWARDSHIP PLAN.
